- We will report data on our greenhouse gas (GHG) emissions consistent with the Greenhouse Gas Protocol.
- We commit, endorse, and include all Responsible Business Alliance (RBA) Code environmental elements including permits and reporting, pollution prevention and resource reduction, hazardous substances, solid waste, air emissions, materials restrictions, water management, and energy consumption and greenhouse gas emissions into our standard operating practices.
- We will promote sustainable energy consumption such as using renewable energy and energy-saving lamps with motion sensors, where applicable.
- Where applicable, we will review biodiversity concerns and address any impacts from our company's operations to the local animals, endangered species, land protected areas and on local ecosystems.
- We will work to minimize waste by implementing recycling and other conservation programs, and we will properly handle and dispose of any hazardous materials and chemicals in accordance with all applicable regulations.
